II. Activities to Promote International Research Exchanges

(1) Hosting of Visiting Research Fellows (VRF)

In this program, academic and other related field specialists exclusively from developing countries are invited to conduct research in Japan as VRFs. This program offers VRFs opportunities to carry out research on developing economies and related issues, exchange opinions and information on development affairs with IDE researchers and learn about the Japanese development experience through activities such as a study tour program and seminars on Japan. In FY2011, the IDE hosted and financially supported seven VRFs and two self-supporting fellows from abroad.

(2) Dispatching of IDE Staff Abroad

(3) Networking Activities

The IDE conducted various international networking activities to serve as a center of excellence for development studies. Activities in FY2011 are summarized as follow.

- Invited four development experts and organized special seminars and discussion meetings.
- Received 32 overseas visitors and organized meetings and seminars.
- Dispatched 30 researchers abroad for annual conventions of academic associations and international conferences.
- Exchanged a Memorandum of Understanding (MoU) with the following three prominent overseas

academic institutions to expand our international research network.

The Ministry of Foreign Affairs of Japan held a conference entitled 'The Second Round of the Dialogue for the Future between Japan and the Islamic World' from 29th February to 1st March in Amman, Jordan. At the conference, IDE organized a session entitled 'The Arab Spring and the Role of the Media', and it facilitated international research exchange and contributed to the development of effective policies in the Middle East. For the conference, IDE dispatched four researchers and invited three specialists from Indonesia, Malaysia and Iran.

In March 2012, to build a research network and improve the curriculum of IDEAS, a field trip to Switzerland and the United Kingdom was completed.
