Global Value Chains (GVC) is a relatively new concept which considers international trade as the flows of value-added in the manufacturing process, not as just the flows of products and services. In 2011, the World Trade Organization (WTO) and IDE-JETRO published "Trade Patterns and Global Value Chains in East Asia" as the results of our joint research. This stimulated increasing interests in GVC among international organizations and foreign governments, and promoted studies on GVC in various research organizations. As a result, a variety of research approaches to this concept has been proposed.

The goal of this international symposium was to review the importance of the concept of GVC by comparing these approaches, and to discuss its implication for trade policy.

Prof. Baldwin, one of the world's foremost researchers on international trade, and Dr. Koopman, USITC's Director of Operations who has an immense influence over trade policy decisions in the US, made keynote speeches and addressed the academic and policy implications of GVC. Following the speeches, a panel discussion was held with experts from the WTO and the Organisation for Economic Cooperation and Development (OECD), and representatives from national trade-policy offices to discuss the impact of the concept on the front line of trade policy and its possible responses.

The symposium was an invaluable opportunity, as the world renowned researchers and the trade policymakers around the world got together to engage in international intellectual exchange and made great contributions to the advancement of research in this field.

Closing Remarks

Steffen KAESER NABESHIMA Kaoru Since 2012, IDE-JETRO, in cooperation with the United Nations Industrial Development Organization (UNIDO), has conducted research on compliance with international trade standards in terms of agricultural and food product exports from developing countries in Asia, by analyzing data on rejection cases provided by the food safety regulatory authorities in developed countries. The results of this research were officially published in December 2013 under the title of "Meeting Standards, Winning Markets, Regional Trade Standards Compliance Report – East Asia 2013." This symposium was held to disseminate the findings from the research prior to the publication.

A variety of stakeholders participated in the symposium, including regulatory authorities on food safety, exporters in developing countries, importers in Japan, and international organizations, and presented challenges from their own points of view. Based on the analysis of data from Asia and field surveys conducted in Vietnam and China, IDE-JETRO led discussions on what kinds of changes corporate efforts for compliance make on supply chains, what are the bottlenecks in each stage of supply chains, and its policy implications.

Mr. Kaeser from UNIDO presented the background and overall design of the global version of the Trade Standards Compliance Report (TSCR), followed by Mr. Nabeshima from IDE-JETRO, who introduced the contents of the East Asian version of the Trade Standards Compliance Report (ATSCR) and discussed its policy implications relevant to East Asian countries. Mr. Imagawa from the MHLW summarized the importance of the food safety standards for Japan and the systems to ensure food safety, from the viewpoint of Japan's food safety regulatory authorities.

In the discussion in Session 2, a representative of fishery industry association in a developing country and a Japanese supplier importing food products from developing countries addressed the current situation, issues, and efforts to overcome food safety issues from their own perspectives. Following these, two case studies from ATSCR are introduced to examine issues associated with the supply chains in Vietnam (cultured shrimps and pangasius) and in China (frozen vegetables). Finally, the symposium was wrapped up by shedding light on challenges in each stage of progress towards compliance, along with their implications.

Panel Summary – Closing Remarks

The compatibility between economic growth and social justice is an important but difficult challenge for every nation and society. In the capitalist economy generally speaking, the prioritization of economic growth leads widening income gaps and diminishing social justice, while an emphasis on welfare and other methods of improving social justice can result in stagnating economic growth.

Brazil, in the beginning of 21st century, accomplished its economically remarkable development, transforming from debtor to creditor country in 2007 and achieving 7.5% GDP growth in 2010. Over the same period, Brazil succeeded in enhancing the social justice like poverty alleviation by improvement of the social security institutions and implementation of the conditional cash transfer programs. In June 2013, Brazil experienced nationwide protest demonstrations; nonetheless, it is attempting to implement structural reform within the state, even drawing lessons from the demonstrations, with the aim of achieving both sustainable economic growth and social justice. Some renowned researchers in the field of Latin American studies have come to regard recent Brazil as "The New Brazil," taking into account stabilized democracy and increasing diplomatic presence as well.

This symposium dealt with the challenges to seek compatibility between economic growth and social justice, focusing on the experiences of The New Brazil, which had once accomplished them in the beginning of 21st century but has faced with its public dissatisfaction exploded in these days.

In the first half of the symposium, three speakers delivered the keynote addresses; Dr. Canuto surveyed the experiences of Brazil in terms of the compatibility between economic growth and social justice, Prof. Levy talked mainly about recent economic trends in Brazil, and Prof. Bugarin argued the protest demonstrations suddenly occurred, in terms of the Citizen Constitution of Brazil in 1988, three years after the shift to civilian rule.

In the latter half, Prof. Horisaka dealt with the recent adjustment phase of Brazilian economy, Ms. Hoshino compared two different approaches to globalizing economy in Brazil and Mexico, and Mr. Konta introduced the social security system in Brazil and the nationwide protest demonstrations in 2013. Finally, all speakers got together to have a discussion about factors for success in the Conditional Cash Transfer program in Brazil, the need to improve industrial labor productivity for further economic growth, and the importance of the presidential and general elections in the next year in Brazil which may mark a turning point for the future.

This International Symposium was co-hosted by the Sophia University on the occasion of its 100th Anniversary Celebrations. It aimed at exploring the European Union (EU) and its global migration strategy, which has resumed acceptance of foreign workforces,

Questions included: what can Asian countries learn from the EU's experiences; how can Asian countries raise the global competitiveness in the highly-skilled labor market; what is the possible regional integration in Asia like? Reviewing the EU's implication, the impacts of introducing foreign workforces. especially highly-skilled labors, on Asian countries were investigated from the perspectives of economy and security.
