1. Hosting of Visiting Research Fellows (VRFs)

In this program, scholars and specialists from both developed and developing countries are invited to conduct research in Japan. This program offers VRFs opportunities to carry out research on developing economies and related issues, exchange opinions and information on development affairs with IDE researchers, and learn about the Japanese development experience through activities such as a study tour program and seminars on Japan and other countries. In FY2016, the IDE hosted and financially supported four VRFs from abroad. In addition, the IDE accepted two VRFs from Japanese universities and one JSPS (Japan Society for the Promotion of Science) research fellow.

(1) Official Side Event "Industrialization, Private Sector Development and Economic Transformation in Africa: Challenge and Prosperity" at TICAD VI in Nairobi

The Sixth Tokyo International Conference on African Development (TICAD VI) was held in Nairobi, Kenya, for two days from August 27 to 28, marking the first time that the conference was held in Africa. IDE-JETRO took advantage of the occasion to hold an official side event for the first time under the title of "Reforming African Economic Structure through Industrialization and Development of the Private Sector." The seminar was co-hosted by the African Economic Research Consortium (AERC) from Nairobi and the Overseas Development Institute (ODI) from the UK. The AERC is an international research consortium that specializes in studying Africa's economy. The ODI is a renowned think tank on international development and humanitarian issues. Approximately 70 people joined the seminar, with over half of the participants coming from African countries.

(2) Working Session at WTO Public Forum 2016: "The Internationalization of Firms and Human Resource Management Practices"

This session explored the mechanism of Global Value Chains participation from firms based on their management practices and using the results from a survey on Vietnamese firms. Special attention was given to human resource management (HRM) practices, such as compensation, recruitment, and job training, to capture the effect of globalization on workers at the firm level. In the session, the effectiveness of government support for firms' activities to improve employee skills was discussed.

(3) Official Side Event "Tracing GHG Emissions in Global Value Chains: A New Horizon in a Post-Paris World" at Japan Pavilion of COP22 in Marrakech

The COP is held annually and is the largest international conference on climate change issues. COP22 received attention due to the Paris Agreement which had been issued just before it was held. At the Japan Pavilion, operated by the Japanese government, a session was held by IDE-JETRO that mainly focused on continuous research that applied its Global Value Chain (GVC)-based analyses into tracing greenhouse gas emissions. This seminar, consisting of two parts with reports from experts and a panel discussion, attracted over 55 participants including a high-level government official.

IDE-JETRO organized a workshop with the JETRO Vientiane Office and National Institute for Economic Research (NIER). The aim of this seminar was to clarify the cost of logistics in Laos. According to the investigation conducted by IDE-JETRO, the cost of logistics in Laos is high compared with other East Asian countries, so the seminar gave its policy recommendation to the Lao government on how to improve its logistical condition.

The above research project conducted a statistical analysis in the Philippines and was intended to disseminate the research findings to cities where the research was conducted. This conference aimed to develop our understanding of the challenges facing Sri Lanka in realizing its potential for economic growth by encouraging export-led industrialization by fully utilizing its trade hub. This conference highlighted the experience of East Asian countries in promoting export industries through measures such as special economic zones (SEZ) to attract industries beyond their borders. It also discussed the impact of free trade agreements, especially on the flow of FDI and the decomposition of global value chains.
