



IDE-JETRO conducts studies on various issues faced by developing countries and regions, funded by operational grants allocated by the government. Research projects are categorized into several types. One category includes basic and comprehensive studies conducted in a workshop format, aiming to generate academic research outcomes. Another involves ongoing analytical research for the purpose of publishing periodicals that take a fixed-point view of a country or region and building and maintaining economic models. In addition, the institute undertakes project-based research initiatives that aim to provide policy recommendations or expand academic networks in specific fields, where the final outputs may take forms other than papers or books. Some research activities are also supported by subsidies and other external funding sources.
