



Slovenia: GDP per capita





China, India, Japan, Indonesia, and United States






Dynamics of 86% Vs. 14%

European Union's Plunging Birthrates Spread Eastward: Decrease in Fertility Rates from 1970 to 2004








More Developed Regions






Top Recipients of Migrant Remittances among Developing Countries




Top Recipients of Migrant Remittances among Developing Countries



Remittance Flow to Developing Countries


