



Taiwan in Indonesia's Export (US\$ billion, 2005-2017)





Ties are strengthening?

- The Taiwan-Indonesia ties are historical.
 - Chinese migrants from Fujian/Fukien (common language, food, therapy, family ties, business experts, etc.)
- After 2017, the New Southbound Policy is pushing the bilateral ties in creating "events".
- But, the impact of the Policy is not yet visible in light of activating the bilateral flows in trade, investment, and people's movement.
